The 'weighted average maturity', or WAM, and 'weighted average life' or WAL, of a fund are measures of the length of time to maturity of all the underlying money market instruments in the fund weighted to reflect the relative holdings in each instrument. For WAM, the length of time to maturity for a floating rate note is determined using the instrument's floating rate reset date. For WAL, the length of time to maturity for a floating rate note is determined using the instrument's maturity date or date of unconditional put.
